EMERGENCY OVERVIEW

Appearance: light-tan crystalline beads solid.

General Information: As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. Product is not combustible until moisture is removed then resin starts to burn in flame at 230 C.

Extinguishing Media: This material is lighter than water and insoluble in water. The fire could easily be spread by the use of water in an area where the water cannot be contained. Use agent most appropriate to extinguish fire. Use water spray, dry chemical, carbon dioxide, or appropriate foam.

Storage: Keep container closed when not in use. Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep moist. Dry ion exchange resins expand when wetted, which may cause column to shatter.
