Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear to light yellow clear liquid.

Danger! Causes eye and skin burns. Causes digestive and respiratory tract burns. Contact with water liberates toxic gas. Water-reactive. Reacts violently with water.

Target Organs: Central nervous system, respiratory system, eyes, skin, mucous membranes.

Potential Health Effects

Eye: Causes eye burns.

Skin: Causes skin burns.

Ingestion: May cause severe and permanent damage to the digestive tract. Causes gastrointestinal tract burns. May cause perforation of the digestive tract. May cause systemic effects.

Inhalation: Causes chemical burns to the respiratory tract.

Chronic: Chronic exposure may cause effects similar to those of acute exposure.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid immediately.

Skin: In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid immediately. Wash clothing before reuse.

Ingestion: If swallowed, do NOT induce vomiting. Get medical aid immediately. If victim is fully conscious, give a cupful of water. Never give anything by mouth to an unconscious person.

Inhalation: Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.

Notes to Physician: Treat symptomatically and supportively.

Section 6 - Accidental Release Measures

Spills/Leaks: Absorb spill with inert material (e.g. vermiculite, sand or earth), then place in suitable container. Avoid runoff into storm sewers and ditches which lead to waterways. Clean up spills immediately, observing precautions in the Protective Equipment section. Provide ventilation. Do not expose spill to water. Do not let this chemical enter the environment.

Section 7 - Handling and Storage

Handling: Do not allow water to get into the container because of violent reaction. Avoid breathing dust, mist, or vapor. Do not breathe dust, mist, or vapor. Do not get in eyes, on skin, or on clothing. Keep container tightly closed. Do not ingest or inhale. Use only in a chemical fume hood. Discard contaminated shoes. Keep from contact with moist air and steam.

Storage: Store in a tightly closed container. Corrosives area. Deep freeze (below -20°C). Store protected from moisture.
