Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: black crystals.

Warning! Irritant. Causes respiratory tract irritation. Causes eye and skin irritation. May cause digestive tract irritation. Hygroscopic (absorbs moisture from the air).

Potential Health Effects

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.
