EMERGENCY OVERVIEW

Appearance: clear very slight yellow liquid. Flash Point: 41 deg C.

Danger! Causes eye and skin burns. Causes digestive and respiratory tract burns. **Flammable liquid and vapor.**

Target Organs: Respiratory system, gastrointestinal system, eyes, skin.

Potential Health Effects

Eye: Causes eye burns.

Skin: Causes skin burns.

Ingestion: May cause severe gastrointestinal tract irritation with nausea, vomiting and possible burns. The toxicological properties of this substance have not been fully investigated.

Inhalation: May cause severe irritation of the upper respiratory tract with pain, burns, and inflammation. The toxicological properties of this substance have not been fully investigated. Vapors may cause dizziness or suffocation.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

Ingestion: Do not induce vomiting. If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Get medical aid immediately. Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

Notes to Physician: Treat symptomatically and supportively.

Keep away from heat, sparks and flame. Do not ingest or inhale. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames.

Storage: Keep away from heat, sparks, and flame. Keep away from sources of ignition. Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances.
