EMERGENCY OVERVIEW

Appearance: clear colorless to pale yellow viscous liquid.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.

Environmental: Terrestrial Fate: Very high mobility in soil. Volatilization is not expected to be important. Aquatic Fate: Acetin is not expected to adsorb to suspended solids, and is not expected to volatilize from water surfaces. The potential for bioconcentration in aquatic organisms is low. Atmospheric Fate: With an estimated vapor pressure of 3.9x10⁻³ mmHg @25°C, it is expected to exist in the atmosphere solely as a vapor. Here it is biodegraded by photochemically-produced hydroxyl reactions with a half life of 23hrs.
