Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Causes respiratory tract irritation. Causes eye and skin irritation. May be harmful if absorbed through the skin. May cause digestive tract irritation.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. May be harmful if absorbed through the skin.

Section 4 - First Aid Measures
