EMERGENCY OVERVIEW

Appearance: yellow orange powder.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Dust may cause mechanical irritation.

Skin: No information regarding skin irritation and other potential effects was found. May be metabolized to cyanide which in turn acts by inhibiting cytochrome oxidase impairing cellular respiration.

Ingestion: The toxicological properties of this substance have not been fully investigated. Metabolism may release cyanide, which may result in headache, dizziness, weakness, collapse, unconsciousness and possible death. Ingestion may result in symptoms similar to cyanide poisoning which is characterized by asphyxiation.

Inhalation: Inhalation of dust may cause respiratory tract irritation. May be metabolized to cyanide which in turns act by inhibiting cytochrome oxidase impairing cellular respiration.

Section 4 - First Aid Measures
