Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: colorless liquid.

Warning! Causes respiratory tract irritation. Lachrymator (substance which increases the flow of tears). Causes eye and skin irritation. May cause digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Causes eye irritation. Lachrymator (substance which increases the flow of tears).

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid. Do NOT allow victim to rub eyes or keep eyes closed.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Section 5 - Fire Fighting Measures
