Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white to off-white solid.

Warning! Causes eye and skin irritation. May be harmful if swallowed. Causes digestive and respiratory tract irritation. Hygroscopic (absorbs moisture from the air). May cause adverse reproductive effects based upon animal studies.

Target Organs: Reproductive system.

Potential Health Effects

Eye: Causes eye irritation.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Do not induce vomiting. If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
