EMERGENCY OVERVIEW

Appearance: off-white to cream flakes.

Warning! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. May be harmful if swallowed.

Target Organs: None known.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation.

Section 4 - First Aid Measures

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
