EMERGENCY OVERVIEW

Appearance: white solid.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material.

Ingestion: May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated.

Inhalation: May cause asthmatic attacks due to allergic sensitization of the respiratory tract. Causes irritation of the mucous membrane and upper respiratory tract.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
