EMERGENCY OVERVIEW

Appearance: white to off-white crystalline powder.

Caution! May cause eye, skin, and respiratory tract irritation. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.

Target Organs: None known.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation.

Ingestion: May cause irritation of the digestive tract. Expected to be a low ingestion hazard.

Inhalation: May cause respiratory tract irritation.

Chronic: Not available. Tumorigenic effects did occur in chronic animal studies. Not considered carcinogenic by ACGIH, IARC, NIOSH, OSHA, NTP or Ca Prop 65.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid.

Skin: In case of contact, flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical aid if irritation develops and persists. Wash clothing before reuse.

Ingestion: If swallowed, do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical aid.
