Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: White - Light Brown Moist Solid.

Caution! Causes irritation of the mucous membranes. Causes respiratory tract irritation. Causes eye and skin irritation. May be harmful if swallowed. Hygroscopic (absorbs moisture from the air).

Target Organs: Kidneys, liver.

Eye: Causes eye irritation.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Do not induce vomiting. If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.
