EMERGENCY OVERVIEW

Appearance: gray to light brown solid.

Warning! Causes eye, skin, and respiratory tract irritation. May be harmful if swallowed. The toxicological properties of this material have not been fully investigated.

Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Section 4 - First Aid Measures
