Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear, colorless to pale yellow liquid. Flash Point: 76 deg C.

Warning! Causes skin irritation. **Combustible liquid and vapor.** May cause eye and respiratory tract irritation. May cause central nervous system depression.

Potential Health Effects

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames. Keep away from heat and flame. Avoid breathing vapor or mist.

Storage: Keep away from sources of ignition. Store in a tightly closed container. Keep refrigerated. (Store below 4°C/39°F.) Store in a cool, dry area away from incompatible substances.
