EMERGENCY OVERVIEW

Appearance: yellow solid. Flash Point: 78 deg C.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Wash mouth out with water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.
