Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white solid.

Caution! Causes eye and skin irritation. May cause respiratory and digestive tract irritation. Hygroscopic (absorbs moisture from the air).

Section 4 - First Aid Measures
