Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: gray-beige crystalline powder.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. May cause central nervous system depression. May cause cardiac disturbances. May cause liver and kidney damage. The toxicological properties of this material have not been fully investigated.

Target Organs: Kidneys, central nervous system, liver, cardiovascular system.

Potential Health Effects

Eye: May cause eye irritation. May cause chemical conjunctivitis and corneal damage.

Skin: May cause skin irritation. Exposure to arsenic compounds may produce hyperpigmentation of the skin and hyperkeratoses of plantar and palmar surfaces as well as both primary irritation and sensitization types.

Ingestion: May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated. Ingestion of arsenical compounds may cause burning of the lips, throat constriction, swallowing difficulties, severe abdominal pain, severe nausea, projectile vomiting, and profuse diarrhea. Ingestion of arsenic compounds can produce convulsions, coma, and possibly death within 24 hours.

Inhalation: May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. Inhalation of arsenic compounds may lead to irritation of the respiratory tract and to possible nasal perforation. Long-term exposure to arsenic compounds may produce impairment of peripheral circulation.

Chronic: May cause liver and kidney damage. Chronic exposure to arsenical dust may cause shortness of breath, nausea, chest pains, and garlic odor.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.

Notes to Physician: Treat symptomatically and supportively.
