### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

**Appearance:** faint yellow to yellow powder.

**Warning!** Harmful if swallowed, inhaled, or absorbed through the skin. Causes eye, skin, and respiratory tract irritation. The toxicological properties of this material have not been fully investigated.

#### Potential Health Effects
