EMERGENCY OVERVIEW

Appearance: Colorless - Slightly Yellow Liquid. Flash Point: 87 deg C.

Caution! Causes respiratory tract irritation. Causes eye and skin irritation. **Combustible liquid and vapor.** May cause digestive tract irritation.

Potential Health Effects

Eye: Vapors cause eye irritation.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Section 5 - Fire Fighting Measures

Section 6 - Accidental Release Measures

Use with adequate ventilation. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames.

Storage: Keep away from heat, sparks, and flame. Keep away from sources of ignition. Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances.
