### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: white powder.

**Warning!** Causes eye and skin irritation. Causes digestive and respiratory tract irritation. May cause central nervous system depression. Hygroscopic (absorbs moisture from the air).

**Target Organs:** Central nervous system.

**Potential Health Effects**

**Eye:** Causes eye irritation.

**Skin:** Causes skin irritation.

**Ingestion:** Causes gastrointestinal irritation with nausea, vomiting and diarrhea. May cause central nervous system depression.

**Inhalation:** Causes respiratory tract irritation. Exposure produces central nervous system depression.

**Chronic:** Laboratory experiments have resulted in mutagenic effects.

### Section 4 - First Aid Measures

**Eyes:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

**Ingestion:** Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

**Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
