EMERGENCY OVERVIEW

Appearance: yellow powder.

Warning! Causes respiratory tract irritation. Causes eye and skin irritation. May cause digestive tract irritation. May cause central nervous system depression.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures
