Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear yellow solid or liquid.

Slowly oxidized by atmospheric oxygen. Gradually darkens on exposure to light. This is expected to be a low hazard for usual industrial handling.
