### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: white to yellow powder.

**Warning!** Causes eye, skin, and respiratory tract irritation. Danger of cumulative effects.

**Target Organs:** Respiratory system, eyes, skin.

#### Potential Health Effects

**Eye:** Causes eye irritation. May cause chemical conjunctivitis.

**Skin:** Causes skin irritation.
