EMERGENCY OVERVIEW

Appearance: off-white powder.

Danger! May be fatal if absorbed through the skin. Harmful if swallowed. Dust causes eye, skin, and upper respiratory system irritation. This substance has caused adverse reproductive and fetal effects in animals.

Target Organs: Gastrointestinal system.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. May be fatal if absorbed through the skin.

Ingestion: Harmful if swallowed. Causes gastrointestinal irritation with nausea, vomiting and diarrhea. May cause gastrointestinal tract damage.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Do not use mouth-to-mouth resuscitation if victim ingested or inhaled the substance; induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
