Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: yellow solid or liquid.

Danger! Causes eye and skin burns. Causes digestive and respiratory tract burns. Harmful if swallowed, inhaled, or absorbed through the skin.

Section 4 - First Aid Measures
