EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Causes eye, skin, and respiratory tract irritation. May be harmful if swallowed. Hygroscopic (absorbs moisture from the air).

Section 4 - First Aid Measures

Ingestion: If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
