### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: yellow orange powder.

**Warning!** Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation.

#### Potential Health Effects

**Eye:** Causes eye irritation. May cause chemical conjunctivitis.
