Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: yellow viscous liquid.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. This is expected to be a low hazard for usual industrial handling.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid if cough or other symptoms appear.
