Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: off-white powder.

Warning! Harmful if swallowed, inhaled, or absorbed through the skin. May cause allergic skin reaction. May cause eye, skin, and respiratory tract irritation. May cause liver and kidney damage.

Section 4 - First Aid Measures
