## Section 3 - Hazards Identification

#### **EMERGENCY OVERVIEW**

Appearance: clear, colorless liquid. Flash Point: 57 deg C.

**Danger!** Corrosive. Causes eye and skin burns. Lachrymator (substance which increases the flow of tears). **Flammable liquid and vapor.** May cause severe respiratory tract irritation with possible burns. May cause severe digestive tract irritation with possible burns. May cause central nervous system depression. Moisture sensitive.

Target Organs: Central nervous system, eyes, skin, mucous membranes.

#### **Potential Health Effects**

**Eye:** Causes eye burns. Lachrymator (substance which increases the flow of tears). May cause chemical conjunctivitis and corneal damage.

**Skin:** Causes skin burns. May cause cyanosis of the extremities. May cause skin rash (in milder cases), and cold and clammy skin with cyanosis or pale color.

## Section 4 - First Aid Measures

## Section 5 - Fire Fighting Measures

Do not get water inside containers. A vapor suppressing foam may be used to reduce vapors.
