Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear, colorless liquid.

Warning! Irritant. Causes eye and skin irritation. May cause respiratory and digestive tract irritation.

Target Organs: None.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Skin: Causes skin irritation.

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea.

Section 4 - First Aid Measures

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.

Section 5 - Fire Fighting Measures

Environmental: Terrestrial: Expected to be immobile in soil. Volatilization from moist soil is expected to be an important fate process. However, adsorption is expected to attenuate volatilization.
