EMERGENCY OVERVIEW

Appearance: yellow lumpy powder solid.

Warning! Causes respiratory tract irritation. Causes eye and skin irritation. May cause digestive tract irritation.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
