Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: yellow crystalline powder.

Warning! Irritant. Causes eye, skin, and respiratory tract irritation. Harmful if swallowed, inhaled, or absorbed through the skin. May cause central nervous system depression. May cause cardiac disturbances. The toxicological properties of this material have not been fully investigated.

Target Organs: Central nervous system, respiratory system, cardiovascular system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Skin: Causes skin irritation. Harmful if absorbed through the skin.

Ingestion: Harmful if swallowed. May cause gastrointestinal irritation with nausea, vomiting and diarrhea. May cause cardiac disturbances. May cause central nervous system depression.

Inhalation: Causes respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. May cause cardiac abnormalities. Inhalation at high concentrations may cause CNS depression and asphyxiation. Harmful if inhaled.

Chronic: There is a danger of cumulative effects.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.
