Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear, colorless to pale yellow liquid. Flash Point: 23 deg C.

Danger! Causes eye and skin burns. Causes digestive and respiratory tract burns. **Flammable liquid and vapor.** Moisture sensitive.

Target Organs: Eyes, skin, mucous membranes.

Potential Health Effects

Eye: Causes eye burns.

Skin: Causes skin burns.

Ingestion: Causes gastrointestinal tract burns. The toxicological properties of this substance have not been fully investigated.

Inhalation: Causes chemical burns to the respiratory tract. The toxicological properties of this substance have not been fully investigated.

Chronic: Chronic exposure may cause effects similar to those of acute exposure.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid immediately.

Skin: In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid immediately. Wash clothing before reuse.

Ingestion: If swallowed, do NOT induce vomiting. Get medical aid immediately. If victim is fully conscious, give a cupful of water. Never give anything by mouth to an unconscious person.

Inhalation: Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.

Section 6 - Accidental Release Measures

General Information: Use proper personal protective equipment as indicated in Section 8.

Spills/Leaks: Absorb spill with inert material (e.g. vermiculite, sand or earth), then place in suitable container. Avoid runoff into storm sewers and ditches which lead to waterways. Clean up spills immediately, observing precautions in the Protective Equipment section. Remove all sources of ignition. Use a spark-proof tool. Provide ventilation.

Section 7 - Handling and Storage

Handling: Wash thoroughly after handling. Remove contaminated clothing and wash before reuse. Use with adequate ventilation. Ground and bond containers when transferring material. Use spark-proof tools and explosion proof equipment. Do not get in eyes, on skin, or on clothing. Empty containers retain product residue, (liquid and/or vapor), and can be dangerous. Keep container tightly closed. Do not ingest or inhale. Discard contaminated shoes. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames. Keep away from heat, sparks and flame.

Storage: Store in a tightly closed container. Refrigerator/flammables. Store under nitrogen.
