Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear slightly yellow clear liquid.

Warning! Harmful if swallowed, inhaled, or absorbed through the skin. May cause eye, skin, and respiratory tract irritation. May cause cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood). The toxicological properties of this material have not been fully investigated.

Target Organs: No data found.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation. May be harmful if absorbed through the skin.

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea. The toxicological properties of this substance have not been fully investigated. May be harmful if swallowed. May form methemoglobin which in sufficient concentration causes cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood).

Inhalation: May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. May be harmful if inhaled. This product contains nitrite which may cause methemoglobinemia.

Chronic: Not available. Effects may be delayed 2 - 4 hours.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
