EMERGENCY OVERVIEW

Appearance: off-white to tan chips.

Warning! Causes eye, skin, and respiratory tract irritation. Moisture sensitive.

Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
