Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: black powder.

Danger! Causes eye irritation. May cause respiratory and digestive tract irritation. May cause skin irritation. Hygroscopic (absorbs moisture from the air).

Potential Health Effects

Eye: Dust may cause mechanical irritation. Causes eye irritation. May cause permanent corneal opacification. May cause chemical conjunctivitis.

Section 4 - First Aid Measures

Ingestion: Do not induce vomiting. If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
