### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

**Appearance:** white to off-white solid.

**Warning!** Irritant. Causes eye and skin irritation. May cause respiratory and digestive tract irritation. Light sensitive. The toxicological properties of this material have not been fully investigated.

**Target Organs:** No data found.

#### Potential Health Effects

**Eye:** Causes eye irritation. Exposure to solid may cause pain and redness. May cause chemical conjunctivitis.

### Section 4 - First Aid Measures
