EMERGENCY OVERVIEW

Appearance: light yellow crystalline powder.

Warning! Causes eye and skin irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. The toxicological properties of this material have not been fully investigated.

Section 4 - First Aid Measures
