EMERGENCY OVERVIEW

Appearance: white crystals.

Danger! Forms sensitive explosive metallic compounds. May become explosive when allowed to dry out. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: May cause eye irritation. The toxicological properties of this material have not been fully investigated.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Section 5 - Fire Fighting Measures

Section 6 - Accidental Release Measures
