EMERGENCY OVERVIEW

Appearance: brick red powder.

Warning! Causes respiratory tract irritation. Causes eye and skin irritation. May cause digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Section 4 - First Aid Measures
