### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: gray-white or reddish metal powder.

**Warning!** Flammable solid. Flammable when exposed to flame. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Air sensitive.

**Target Organs:** None.

#### Potential Health Effects

**Eye:** May cause eye irritation.

**Skin:** May cause skin irritation.

### Section 4 - First Aid Measures

**Eyes:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

**Skin:** Get medical aid immediately. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

**Ingestion:** If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

**Inhalation:** Get medical aid immediately. Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
