Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: brown-red solid.

Warning! Harmful if swallowed. Causes eye, skin, and respiratory tract irritation. May cause allergic skin reaction.

Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures
