Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: clear dark brown clear liquid.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. May be harmful if swallowed. May cause cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood).

Target Organs: No data found.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Skin: Causes skin irritation. Absorption into the body may cause cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood).

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea. May form methemoglobin which in sufficient concentration causes cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood).

Inhalation: Causes respiratory tract irritation. Can produce delayed pulmonary edema. Inhalation of aniline causes anoxia due to the formation of methemoglobin.

Chronic: Effects may be delayed.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Notes to Physician: Treat symptomatically and supportively.
