EMERGENCY OVERVIEW

Appearance: yellow to orange powder.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Air sensitive. Moisture sensitive. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation.

Ingestion: May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated.

Inhalation: May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. This product contains nitrite which may cause methemoglobinemia.

Chronic: Prolonged exposure may cause anemia and methemoglobinemia, characterized by dizziness, drowsiness, headache, breath shortness, cyanosis (bluish skin due to deficient oxygenation of the blood), rapid heart rate and chocolate-brown colored blood.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
