EMERGENCY OVERVIEW

Appearance: tan powder.

Warning! Causes eye and skin irritation. Causes digestive and respiratory tract irritation. Moisture sensitive. The toxicological properties of this material have not been fully investigated.

Section 4 - First Aid Measures

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.
