EMERGENCY OVERVIEW

Appearance: light gray solid.

Caution! May cause eye and skin irritation. May cause respiratory tract irritation. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Dust may cause mechanical irritation. May cause conjunctivitis.

Section 4 - First Aid Measures
