Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white solid. **Caution!** The toxicological properties of this material have not been fully investigated. May cause eye and skin irritation. May cause respiratory and digestive tract irritation.

Section 4 - First Aid Measures
