Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Causes respiratory tract irritation. Causes eye and skin irritation. May cause digestive tract irritation. Hygroscopic (absorbs moisture from the air).

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
